As of 2021, FAF is owned and run by a [voluntary association](#) registered in Denmark, consisting of members of the FAF community. The association is responsible for the organization and continued existence of the FAF infrastructure and community. Any person interested in FAF and sympathetic with our mission as described in the statutes is welcome to become a member of the association and participate in the General Meeting, provided they are above 18 years old. At the General Meeting, the members of the association will elect a board who is responsible for managing the day to day business of FAF throughout the coming year, as well as voting on any proposals that are brought to the meeting.

- **Minute taker**  
Responsible for recording the discussions and vote results

## Proposals to the General Meeting

Any member of the association may submit a proposal for deliberation during the General Meeting. Such proposals are to be submitted to the president in written form at least 14 days prior to the meeting, though even if you are late please submit your proposal regardless.

## Association Board members

There is no deadline for announcing candidacy for the board, however candidates are encouraged to make their runs known early and be open to questions and discussion with the Association at large. ## Voting procedure:

- The chairperson will write a message describing the question and voting options.
- Association members vote on the options via discord in a quick time frame. A member is allowed multiple votes on the same question.
- The minute taker takes note of the results in the minutes. The noted results are binding.
- In case of a deadlock the chairperson is allowed an additional vote to break a tie.
- If a member requests it, the vote may be performed instead via a written secret ballot, in which case a strawpoll or similar will be made for the purpose of anonymity.
- Any other ambiguities relating to the voting procedure are to be resolved by the chairperson if they occur.
